At Halleck Creek Ranch we focus on what people can do. We work with our participants to identify and achieve personal goals, allowing them to reach beyond their disability, and celebrate their capabilities. (See Schedule O)

In 2020, we were able to offer one full session (8 weeks) of our therapeutic riding program prior to pausing in March when the shelter-in-place order was instated. Throughout the initial weeks of the pandemic, our organization, our 60-acre ranch, and our 18 horses were managed and cared for exclusively by our management team of four. After creating new systems and policies to safely allow our volunteers to return to the ranch, our dedicated team of 50 volunteers provided daily training, exercise, grooming and socialization to our therapy horses.

From March - December we held weekly free zoom calls for our community where the participants made new friends, learned new social skills, and learned more about how to take care of a horse. (continued below)

Filled with love, laughter, and silliness, these calls provided everyone, including staff, with respite from the isolation, stress and worry caused by the pandemic. From May - October we provided our free in-person "Back to the Barn" visits safely outdoors, masked and at 6-feet of distance. These visits allowed our participants and their whole family to once again receive therapeutic interactions from their favorite horses.

Due to the nature of their needs, most of our students require volunteer side-walkers to provide them with physical, emotional and social support throughout their horseback ride. Because of the social distancing mandate, by November we created a new lesson program and were able to safely offer one full session (8 weeks) of one-on-one "Groundwork" lessons (continues)

where participants could learn to groom, care for, and at times, lead our horses from the ground while maintaining six-feet of distance from others. Despite the challenges Halleck Creek Ranch faced due to the pandemic, we were able to offer services all year long in a safe environment to each individual in our inherently at-risk community. Coming from seven Bay Area counties including Alameda, Contra Costa, Marin, Napa, San Francisco, Solano, and Sonoma, we served 75 participants ranging in age from 5-84, with at least 50% of our ridership being under the age of 18. Participants present with a range of challenges including cerebral palsy, autism spectrum disorder, mood disorders, multiple sclerosis, Down syndrome, blindness, developmental delay and a number of others.

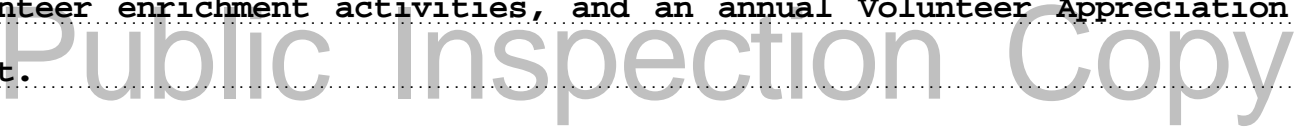
