In 2022, we successfully continued to re-grow our program capacity in the wake of the Covid-19 pandemic, serving 30% more individuals than we did in 2021. New programs and events included a partnership with both Veterans and Equines Together, as well as Swords to Plowshares, to serve previously unhoused veterans through equine facilitated psychotherapy, and a Spring Open House for our greater community, featuring tours of our ranch and riding demonstrations. In September 2021 during our annual dinner and auction event, we successfully raised funds to support our Fire Preparedness Initiative. This enabled us to successfully purchase an additional horse trailer, install water tanks to store 20,000 gallons of fresh water, and acquire other supplies needed to keep our ranch and animals safe during the 2022 fire season, and for years to come. We also successfully completed the installation of a new section of sensory trail, which was thoughtfully named the "Little Six Trail" after one of our beloved horses who passed earlier in the year. This new trail features blooming lavender mixed with trailing rosemary, a pathway with three consecutive sections of various types of footing (sand, gravel, and a wooden bridge) the students can ride their horses through, and engaging games along the way. This new section of trail encourages our students to practice the riding and horsemanship skills they've learned in the arena, while allowing them to step outside of their comfort zone and experience all the sights, sounds, and smells that nature has to offer.
